- B. Treasurer Report: For July-August 2022, bank balances at month end are \$17,209.54 for AICLA, and \$11,973.88 for Save the Lake. Major expenses during the period, such as the \$1,675.00 cost for the full color August newsletter, the web site design fee of \$2,000, coupled with an average membership renewal rate, resulted in a net reduction in the AICLA account of \$4,490.23. The Save the Lake account increased in value by \$387.00.
- C. Membership Report: Membership as of 8/31/22 was 245 members. Seventy (70) members from the 2021/2022 membership roster have yet to renew. For comparison, at this time last year, the membership stood at 239 members.

- D. Transition-Membership: Transitional period starting fall-2022 of the Membership position from Sharon Vaughn to Chuck Kowalski. Sharon Vaughn will be retiring May 2023.
